Penofin RenewAll

Penofin RenewAll brings old, worn wood and concrete to life. The thick elastomeric formula will fill cracks up to ¼" and correct unsightly splinters creating an attractive non-slip, non- skid and dirt resistant surface. PenofinRenewAll is for horizontal surfaces and will add years to the life of any deck, patio or porch.

Coverage: Approximately 75 sq.ft. per gallon. Requires 2-coats. Square feet can be calculated by multiplying length times width; i.e., 10' W X 25' L = 250 sq. ft.

Surface Preparation: For a flawless application, Penofin RenewAll must be able to adhere. Remove any loose splinters and replace rotting or severely damaged boards. Prepare stained, or weathered surfaces with Penofin Pro-Tech Cleaner. If the surface is severely weathered, sand to completely remove all loose wood fibers. Fill cracks larger than ¼" with exterior wood filler. New concrete or masonry surfaces should cure for 30 days before application, then treat with Penofin Pro-Tech Brightener.

Penofin RenewAll is not recommended for driveways or garage floors. Mildew stains and other organic stains should be cleaned with Penofin Pro-Tech Cleaner. Mildew stains are not caused by the coating or coating failure. Penofin – Renew All contains mildew inhibiting agents that protect the coating's film from mildew growth.

Application: Shake and stir thoroughly before and during use. If your project requires more than 1, container, blend all containers together to ensure uniformity of color. Use a nylon or polyester brush to apply Penofin RenewAll into cracks and rough areas before rolling. Use a 3/8" nap roller to apply a thick, even coat, lengthwise along the boards. PenofinRenewAll will dry in 4-6 hours, then apply a second coat. For best results on vertical surfaces, use Penofin 100% Acrylic Solid Stain which is available in complimentary colors.

Do not apply in direct sunlight, to hot surfaces or if the temperature is below 50 degrees Fahrenheit or may fall below 50 within 48 hours of application. Do not apply over wet or damp surfaces or when rain is imminent. Do not intermix with any other products or thin. Protect containers from freezing. For exterior use only.

Cleanup and Disposal: Clean brushes and equipment with soap and water. Dispose of empty cans or unused portion in accordance with local, state and federal regulations.
